RESOLUTION NO. 61

"WHEREAS, a claim for payment of rentals of buildings used as classrooms of the Can-adieng Elementary School has been presented before this Board by Mrs. Consuelo T. Fiel, whose house had been used as classroom by the Grade Six class of Can-adieng from June 14, 1954 to April 1, 1955, and Mrs. Patrocinio P. Omega, whose house had been used as classroom of the Grade Five class of the same school, from June 14, 1954 to April 1, 1955;

"WHEREAS, the contract and agreement entered into by the City Mayor in behalf of the city government and the owners of the buildings above mentioned, stipulated a monthly rental of ₱8.00 for each building; and

"WHEREAS, this Board sees that the aforesaid claim is justifiable, the fact that the same is an obligation of the city to these claimants;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱153.06 from out of the salary savings of positions created in the current annual budget but unfilled until the present, to be made available for the payment of rentals of the buildings owned by Mrs. Consuelo T. Fiel and Mrs. Patrocinio P. Omega, above mentioned;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Division Superintendent of Schools, Tacloban; the City Treasurer, the City Auditor and each to Mrs. Consuelo T. Fiel and Mrs. Patrocinio P. Omega, Can-adieng, all of Ormoc City.

"CARRIED, Unanimously."


