RESOLUTION NO. 62

"WHEREAS, this Board sees that the claim is in order and that the same should be paid as soon as funds are available for the payment of road right-of-way claims;


"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Gutierrez and Vice Mayor Mejia;

"CARRIED, Unanimously."


