RESOLUTION NO. 65

"WHEREAS, Councilor Larrazabal invited the attention of the Presiding Officer, His Honor, the City Mayor, and the other members of the Board, of a certain fireman, Mr. Celerino Baul, who was suspended as such fireman on the strength of his being one of the persons who were accused in a criminal case of Murder in Case No. 227-0 before the Court of First Instance of Ormoc City;

"WHEREAS, the said Fireman Celerino Baul was suspended from office on April 18, 1956 by former Mayor Potenciano Larrazabal, and during his suspension, he was deprived of his monthly salaries until he was acquitted of the charge and reinstated to his position by order of the Court promulgated on August 14, 1957;

"WHEREAS, in view of the acquittal of Mr. Baul of the charges against him, it appears that he is entitled to collect his pay during the period of his suspension;


"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the sum of ₱1,115.32 or so much thereof as may be necessary, from out of the salary savings of any and all the city departments, to be made available for the salary of Fireman Celerino Baul during the period of his suspension from April 18, 1956 to August 15, 1957;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the Fire Chief, and Mr. Celerino Baul, all of Ormoc City.

"CARRIED, Unanimously."


