RESOLUTION NO. 66

of
"WHEREAS, the widow the late Susano Suson, a campaign clerk in the Assessment Division, Office of the City Treasurer, Ormoc City, who died in an automobile accident while on tax collection campaign duty, claimed for benefits or whatever compensation she may be entitled to in accordance with existing laws;

"WHEREAS, City Treasurer Menando J. Tavera, the Chief of Office of the deceased campaign clerk, in an indorsement relative to the matter, recommended compensation in the form of reasonable burial expenses and of six months salary or wages, pursuant to the provisions of Section 699 of the Rev. Adm. Code, as amended by Republic Act No. 1232; and

"WHEREAS, with the aim in view of extending justice to the heirs of the late Susano Suson and considering that it has been found that the deceased met death while on official duty, this Board favors the recommendation of the City Treasurer, subject to the approval of the Secretary of Finance;


"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P150.00 to represent as burial expenses, and the sum of P480.00 to represent six (6) months salary of the late Susano Suson, a Campaign Clerk in the Assessment Division, Office of the City Treasurer, Ormoc City, who died while on tax collection campaign duty, from out of any funds existing in the city treasury not otherwise appropriated, to be paid to the heirs or the widow of the deceased;


"RESOLVED FINALLY, to forward this resolution to the Secretary of Finance for approval, and a copy be furnished to the City Treasurer, another copy for the City Auditor, and still another one for the widow, Mrs. Candida D. Vida de Suson, all of Ormoc City.

"CARRIED, Unanimously."


