"AND, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Samson;



"RESOLVED FINALLY, to furnish copies of this resolution each to Engr. Ramon B. Perez, Waterworks District Engineer, Tacloban; Engr. Nestor C. Penserga, Waterworks Supervisor, Ormoc City; and still another copy be forwarded to the General Manager, National Waterworks and Sewerage Authority, Manila, for his information.

"CARRIED, Unanimously."


