"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Parrilla and Gutierrez;


"RESOLVED, as it is hereby resolved, to amend Resolution No. 61, current series, to read as follows:

"CARRIED, Unanimously."


