RESOLUTION NO. 70

"WHEREAS, the subscriptions to periodicals for the City Library are about to expire;

"WHEREAS, the City Librarian has advised this Board that the subscription to the Philippine Herald, a Manila daily, will expire within this month, and other periodicals which were subscribed for one year last May, 1957; and

"WHEREAS, in order not to stop the regular supply of periodicals for the City Library, it would become necessary to renew their subscription, and if possible, subscribe to some magazines and newspapers which are not as yet subscribed by the City Library;

"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Larrazabal;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P130.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the subscription for one year, to the Manila Times, a Manila daily, to the Philippines Free Press, a Manila Weekly, to the Confidential, a Manila Tabloid, and to the Ormoc Times, a local newspaper;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the City Librarian, all of Ormoc City.

"CARRIED, Unanimously."


