RESOLUTION NO. 76

"WHEREAS, according to the said petition, the nearest water supply is Dayhagan proper, which is some one and a half kilometers away; and

"WHEREAS, taking into consideration the number of residents in the said place and also the distance at which they will have to travel to the nearest source of water, this Board sympathizes with the needs of the people of barrio Juaton-Dayhagan and deems it urgent that an artesian well be dug in the said place;


"NOW, THEREFORE, the Board on motion of Councilor Ocubillo, seconded by Councilor Du;

"CARRIED, Unanimously."


