RESOLUTION NO. 77

"WHEREAS, this Board, through a resolution, has requested the NWSA to bring the water supply of barrio Margen from its source at the barrio outskirts about one and a half kilometers away to the barrio proper through pipes;

"WHEREAS, Councilor Penserga manifested that the NWSA Waterworks Supervisor at Ormoc City has informed him that the pipes are now ready to be laid but the labor in laying these pipes should be furnished; and

"WHEREAS, with the aim in view of helping the barrio people of Margen in their plight for a decent water supply, this Board considers furnishing the labor for the laying of the pipes for the Margen Waterworks, which is estimated at about P800.00;


"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P800.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of salaries and wages for the construction of the Margen Waterworks at barrio Margen, this City;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the Waterworks Supervisor, and the Barrio Lieutenant of Margen, all of Ormoc City.

"CARRIED, Unanimously."


