"WHEREAS, records in the Office of the City Treasurer shows that there is sufficient amount in the Ormoc City High School Fund to cover the payment;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"CARRIED, Unanimously."


