RESOLUTION NO. 72

"WHEREAS, this Board in its regular session held on March 14, 1958, passed Resolution No. 34, awarding the contract for the construction of the proposed slaughterhouse in Bo. Alegria and the proposed market tienda at Bo. Valencia, to Mr. Antolin A. Jariol of Cebu City;

"WHEREAS, in awarding the said contract to Mr. Jariol, who was only the second lowest bidder, this Board took into consideration the fact that Mr. Jariol was a tested contractor who successfully completed the new market buildings in this City, whereas Mr. Sanchez, the lowest bidder, was believed by this Body to be the same Sanchez who constructed the Ormoc Elementary School building whose workmanship had been subject to several criticisms;

"WHEREAS, the truth of the matter as it was found out later, is that Mr. Fortunato Sanchez, who actually won the bid, is another Sanchez and not the one who constructed the Ormoc Elementary School building, a contractor whose workmanship had already been tested in the provinces of Agusan, Surigao and Misamis Oriental; and

"WHEREAS, this Board in considering the matter more carefully, resolved that the awarding of the contract for the construction of the above mentioned projects should not go to Mr. Antolin A. Jariol, who was the second lowest bidder, but to the lowest bidder, Mr. Fortunato Sanchez;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilors Samson and Tan, Jr.;

"RESOLVED, as it is hereby resolved, to repeal Resolution No. 34, current series, of this Board.


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Engineer, the City Treasurer, the City Auditor, all of Ormoc City; Mr. Antolin A. Jariol, 2nd Floor, Quirino Rodriguez Bldg., Cebu City; and Mr. Fortunato Sanchez, Butuan City;

"CARRIED, Unanimously."
