I have the honor to request that honorable body that the
amount of Two Hundred Fifty (P250.00) pesos be appropriated for
emergency purchase of materials needed for emergency repair of
the ceiling of the City Jail, this City.

This request is motivated to forestall any future jail
breaks as the ceiling of the City Jail is already deteriorating
and is no longer safe as far as the accurity of the jail is con-
cerned.

1958, corresponding to the aforementioned request.

"CARRIED, Unanimously."


