RESOLUTION NO. 84

"WHEREAS, there is an urgent need of one who should take charge of the distribution of fertilizers allocated for Ormoc City in order to facilitate the request of the small farmers for fertilizer so as to bolster their production;

"WHEREAS, this Body sees the necessity of making representations with the Department of Finance to seek the approval of the said position, as well as that of the City Assessor created in Resolution No. 48, c.s.;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Ocubillo and Tan, Jr.;


"RESOLVED, as it is hereby resolved, to authorize Vice Mayor Mejia and Councilor Du, both members of this Board, to proceed to Manila to make representations with the Secretary of Finance, to request for the approval of the positions of Agricultural Adviser and Fertilizer in Charge in the Office of the City Mayor, as embodied and created in the current annual budget, and that of the City Assessor created in Resolution No. 48, c.s., in view of the necessity of these positions in order to bolster the production and income of Ormoc City;

"RESOLVED FURTHER, to appropriate the sum of P600.00 from out the salary savings of positions created in the current annual budget unfilled until the present, to be made available for the traveling expenses of the two members of this Board to Manila;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer and the City Auditor, both of Ormoc City.

"CARRIED, Unanimously."


