RESOLUTION NO. 86

"WHEREAS, after collecting the aforestated amount of P150.00 equivalent to a period of 61 days, Mr. Bermejo still has a balance collectible for 66 days, with a money value of P158.75 covering the period from July 1, 1958 to September 4, 1958, inclusive; and

"WHEREAS, the fact that Mr. Bermejo is already out of the service, he should be paid of his accumulated leaves;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Penserger;

"CARRIED, Unanimously."


