RESOLUTION NO. 89

"WHEREAS, the position of Clerk of the Fire Department has been inadvertently omitted in the current annual budget of this City;

"WHEREAS, in view of its omission in the said budget, it would seem that the said position has been proposed to be abolished;

"WHEREAS, the fact that the Department of Finance has disapproved the abolition of positions in the budget, it remains therefore, that the position of Clerk in the Fire Department still exists in the budget;

"WHEREAS, its occupant, Mr. Felipe Chambers, who was appointed to the position in 1953, was illegally terminated by then Acting Mayor Roberto Almaden in 1954; and

"WHEREAS, in view of his illegal termination from the service by former Acting Mayor Almaden, Mr. Felipe Chambers filed a civil suit with the Court of First Instance at Ormoc City, the outcome of which the Court, in its decision or Order issued on June 4, 1958, ordered the incumbent City Mayor to reinstate Mr. Chambers to his position; and

"WHEREAS, this Body sees no other alternative than to comply with the Order of the Court to restore Mr. Chambers to his position;

"NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to fill the position of Clerk of the Fire Department formerly occupied by Mr. Felipe Chambers, and for which he was terminated illegally, in accordance with the Order of the Court of First Instance issued on June 4, 1958;

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and the Fire Chief, all of Ormoc City.

"CARRIED, Unanimously."
