RESOLUTION NO. 96

"WHEREAS, the barrio people of Valencia, in their desire to repair the said buildings, has presented a petition before this Board thru the Barrio Lieutenant requesting a city aid in the amount of ₱800.00 for the purchase of materials necessary for said repairs; and

"WHEREAS, this Board, in approving the request, has in mind to protect the school children's health by housing them in a building that should protect them not only during sunny days but also during the rainy season;


"NOW, THEREFORE, the Board, on motion of Councilor Larrazabal, seconded by Councilor Du;



"CARRIED, Unanimously."


