RESOLUTION NO. 100

"WHEREAS, this Body had information that there is now available for expenditure, the amount of about ₱8,000.00 for the construction of a school building for Can-adieng, this City;

"WHEREAS, this Body was made to understand that despite the fact that the said amount has long been available for disbursement, the same could not be utilized because the site on which the school house is to be built, is not yet owned by the government; and

"WHEREAS, this Body still remembers that the lot presently occupied by the Can-adieng Community School which is still in the name of the late Fr. Ismael Cataag, has been exchanged by the former Municipal Council of the municipality of Ormoc, with lots owned by the then municipal government known as Lot Nos. 1482, 663 and 1530 of the Ormoc Cadastre located in Conception St; and

"WHEREAS, what is only needed now is to formally effect a Deed of Exchange with the heirs of the late Fr. Ismael Cataag;

NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Gutierrez, Du, and Ocubillo;


"RESOLVED, as it is hereby resolved, to effect a Deed of Exchange of lot No. 1575 in the name of the late Fr. Ismael Cataag and which is presently occupied by the school of Canadieng, with the city lots located in Conception St. known as Lot Nos. 1482, 663 and 1530 of the Ormoc Cadastre;

"RESOLVED FURTHER, to request the City Attorney, to prepare and execute the Deed of Exchange;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Attorney, the City Treasurer, the City Auditor, the barrio lieutenant of Can-adieng, and Mr. Donato Cataag, one of the heirs of the late Fr. Cataag, all of Ormoc City.

"CARRIED, Unanimously."


