RESOLUTION NO. 102

"WHEREAS, this Body, in its regular session held on June 13, 1958, passed Resolution No. 87, c.s., appropriating the sum of ₱200.00 from out of the unappropriated balance of the City Intermediate School Fund, for the repair of the temporary building of the Catayum Community School which houses the intermediate grades;

"WHEREAS, after making a list of all the materials needed for such repairs, it has been found out that the amount of ₱200.00 appropriated for the purpose, will not be enough and is deficient still in the amount of about ₱200.00 more; and

"WHEREAS, the Honorable City Mayor who made an ocular inspection of the building aforementioned, manifested before this Board that the said building is such in a dilapidated condition that it would be impossible to hold classes during rainy days without endangering the health of the pupils and teachers; further stating that the additional amount requested will just be about sufficient;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate an additional of ₱200.00 to the amount already appropriated in Resolution No. 87, c.s., from the same source of fund mentioned in the first paragraph herein, and for the same purpose for which the original ~~amount~~ appropriation has been made.



"CARRIED, Unanimously."


