RESOLUTION NO. 102

"WHEREAS, this Body, in its regular session held on June 13, 1958, passed Resolution No. 87, c.s., appropriating the sum of \$200.00 from out of the unappropriated balance of the City Intermediate School Fund, for the repair of the temporary building of the Catayum Community School which houses the intermediate grades;

WHERE IS the Honorable City Mayor who made an occular inspection of the building aforementioned, manifested before this Board that the said building is such in a dilapidated condition that it would be impossible to hold classes during rainy days without endangering the health of the pupils and teachers; further stating that the additional amount requested will just be about sufficient;

"NAW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate an additional of \$200.00 to the amount already appropriated in Resolution No. 87, c.s., from the same source of fund mentioned in the first paragraph herein, and for the same purpose for which the original property appropriation has been made.

"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, the Head Teacher of Catayum Community School and the Barrio Lieutenant of Catayum, all of Ormoc City.

"CARRIED, Unanimously."
