RESOLUTION NO. 103

"WHEREAS, the Candalong Organization, thru its Barrio Lieutenant, has filed a request with this Body thru the Honorable City Mayor, for a permit to hold amusement games in conjunction with their barrio festivities from July 11-17, 1958;

"WHEREAS, the same request also stated that their amusement games, if permitted, be held at the side of the public Tennis Court; and

"WHEREAS, this Body has no objection on the holding of the requested amusement games to coincide with the barrio festivities of Candalong, but the fact is, when it comes to permit it is the City Mayor who is vested with the power to issue the same;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Ocubillo, Gutierrez and Du;

"RESOLVED, as it is hereby resolved, to authorize the Honorable City Mayor to grant a permit to the people of Candalong thru their Barrio Lieutenant, to hold amusement (feria) games at the Tennis Court, in connection with the celebration of the Candalong festivities, from July 11 through 17, 1958;

"CARRIED UNANIMOUSLY."


