RESOLUTION NO. 104

"WHEREAS, Councilor Du invited the attention of the Board to the presence of the barrio lieutenants of barrios Pikoy and Manlilinao, both of this City, whose purposes in coming to this Board is to request that they be given steel cables or galvanized wire to serve as a line to hold bancas ferrying people across the Pagsangan River in Pikoy, and across the Manlilinao River in Manlilinao;

"WHEREAS, this body considering that this is a rainy season and every now and then it rains causing the rivers above mentioned to overflow its banks and cause strong currents, such that without a line to hold on, it would be impossible to cross these rivers, deems it urgent to furnish the requested wires in order to protect the lives of people ferrying across these rivers;


"AND, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P70.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the purchase of steel cables or galvanized wires for the use of barrios Pikoy and Manlilinao and for the purposes aforesaid;



"CARRIED, Unanimously."


