RESOLUTION NO. 106

"WHEREAS, a road right-of-way agreement has been entered into by and between the Honorable City Mayor in behalf of the city government and Mrs. Genoveva Bantasan and Mr. Ramon Bantasan as landowners for a lot used by the city government to widen Osmeña St.;

"WHEREAS, the said lot (Lot No. 592) which is located at the corner of Real St. and runs its length along Osmeña St., is within the 'commercial zone';

"WHEREAS, in view of the location of the lot, the owners thereof are claiming payment at the rate of P20.00 per square meter, which this Body deems fair in view of the foregoing;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Parrilla;

"RESOLVED, as it is hereby resolved, to approve the claim of Mrs. Genoveva Bantasan and Mr. Ramon Bantasan for payment of their lot, subject of the above mentioned road right-of-way agreement, consisting of 19 square meters (the whole of Lot No. 592) at P20.00 per square meter, hereby setting aside the sum of P380.00 should funds become available for the purpose;
