RESOLUTION NO. 109

"WHEREAS, this Body considers that the only hope of the Ormoc Puericulture Center and Maternity House for a visible improvement is an aid from Charity;


"NOW THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilors Larrazabal and Tan, Jr.;



"CARRIED, Unanimously."


