RESOLUTION NO. 110

"WHEREAS, the present transportation facilities between  
Ormoc City and Camotes Islands and vice versa is very inadequate  
and inconvenient;

"WHEREAS, the applicant, Apolonio N. Sevilla has registered  
in the Bureau of Customs three motorboats, namely, San Antonio,  
San Rafael and San Pedro San Pablo for the operation of such fer-  
ry boat service;

"WHEREAS, the said motorboats, San Antonio, San Rafael and  
San Pedro San Pablo, are sufficiently motored, conveniently cons-  
tructed for passenger and freight and with satisfactory accommoda-  
tions; and

"WHEREAS, the management and personnel of such motorboats are  
courteous, accommodating and offerers of good and dependable service  
for the best convenience of the public and public interests;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez,

"CARRIED, Unanimously."


