RESOLUTION NO. 114

"WHEREAS, this Board had information that the artesian well allotted for barrio Manlilinao was dispensed with in view of a promise that the same will be replaced by a waterworks system;

"WHEREAS, it must be known that barrio Manlilinao has been making representations with this Board requesting that they be given the facilities of a decent water supply as do other barrios, but the fact that when it comes to waterworks it is the concern of the NWSA, this Board cannot do anything but to request the NWSA to attend to the plight of the barrio people; and

"WHEREAS, it has come to the knowledge of this Board thru information, that Manlilinao has a good source of water supply for a waterworks system;

NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Gutierrez and Penserga;


"RESOLVED, as it is hereby resolved, to request the Waterworks Supervisor, NWSA, Ormoc City, to undertake a survey of barrio Manlilinao and barrio Pikoy, both of this City, for a water supply which could amply supply these barrios of water;

"RESOLVED FURTHER, to request the Waterworks Supervisor, to submit his findings and recommendation to this Board, as to the means by which these barrios could be amply supplied with water;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Waterworks Supervisor, NWSA, Ormoc City; and the barrio lieutenants of Manlilinao and Pikoy, both of Ormoc City.

"CARRIED, Unanimously."
