RESOLUTION NO. 118

"WHEREAS, Councilor Du manifested that there is a need of sending a City Councilor to Manila as representative of Ormoc City to secure the release of some amount for the irrigation projects for Ormoc City, as well as to follow up the fire truck allotted for Ormoc City which will arrive from Japan next month;

"WHEREAS, in view of the necessity of making representations in order to facilitate the release of the above mentioned project and the fire truck allocation, this Board sees the necessity of sending a member of this Board to Manila, in the person of Councilor Emilio C. Penserga for the purpose;


NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to authorize Councilor Emilio C. Penserga to proceed to Manila at his earliest convenience, to follow up the irrigation projects for Ormoc City and the fire truck allocated for Ormoc City, hereby appropriating for the purpose the sum of P300.00 from out of the 'Traveling Expenses' of the Municipal Board, for the subsistence and transportation expenses of Councilor Penserga to Manila and return;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor and Councilor Penserga, all of Ormoc City.

"CARRIED, Unanimously."


