RESOLUTION NO. 119

"WHEREAS, Councilor Tan, Jr., manifested before this Body that there is incorporated in Republic Act 1900 the sum of ₱10,000.00 which is earmarked for the improvement and repair of the Dolores Waterworks System, Ormoc City;

"WHEREAS, the said waterworks system has failed to function during the last few months, so that this will be the time when the afore stated amount is most needed in order to restore the normal functions of the system;


NOW, THEREFORE, the Board, on motion of Councilor Tan, Jr., seconded by Councilor Gutierrez and Parrilla;

"RESOLVED, as it is hereby resolved, to request the National Waterworks and Sewerage Authority management, Manila, to expedite the release of the amount of ₱10,000 incorporated in RA 1900, so the ~~the~~ amount can be used for the emergency repair of the Dolores Waterworks System, Ormoc City, which for the last few months has failed to function;


"RESOLVED FINALLY, to furnish copies of this resolution each to the General Manager, National Waterworks and Sewerage Authority, Manila; the Waterworks District Engineer, Tacloban City; the Waterworks Supervisor, Ormoc City; and the barrio lieutenant of Dolores, Ormoc City.

"CARRIED, Unanimously."


