RESOLUTION NO. 122

A RESOLUTION REQUESTING CONGRESSMAN DOMINADOR M. TAN
FOR AN AID OF ₱10,000.00 FOR THE CONSTRUCTION OF
A GRANDSTAND AT THE ORMOC CITY CENTRAL SCHOOL ATH-
LETIC GROUNDS.

"WHEREAS, the Division Superintendent of Schools for
Leyte has offered to hold the 1958 Provincial Meet of Ley-
te at Ormoc City;

"WHEREAS, the most important requisite for a certain
place to hold or sponsor a Provincial Meet according to
the Division Superintendent, is a grandstand, aside from
a sufficient athletic ground which the Ormoc City Central
School already has; and

"WHEREAS, Ormoc City is financially hard pressed this
time that it would seem impossible for the city to cons-
truct the required grandstand all by herself;


"NOW, THEREFORE, the Board, on motion of Councilor
Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to request
Congressman Dominador M. Tan of the 2nd District of Ley-
te, now in Manila, to give an aid to Ormoc City in the
amount of ₱10,000.00 for the construction of a grandstand
to be used for the incoming Leyte Provincial Meet some-
time between October and November of this year, said
grandstand to be constructed at the Ormoc City Central
School athletic grounds where the meet will be held;


"RESOLVED FINALLY, to forward a copy of this reso-

"CARRIED, Unanimously."


