RESOLUTION NO. 123

A RESOLUTION REQUESTING THE HONORABLE DANIEL Z. ROMUALDEZ, SPEAKER OF THE HOUSE OF REPRESENTATIVES, MANILA, AN AID OF ₱10,000 FOR THE IMPROVEMENT OF THE ORMOC CITY CENTRAL SCHOOL ATHLETIC GROUNDS PREPARATORY TO THE HOLDING OF THE 1958 LEYTE PROVINCIAL MEET AT ORMOC CITY SOMETIME BETWEEN OCTOBER AND NOVEMBER, THIS YEAR.

"WHEREAS, the 1958 Leyte Provincial Meet is proposed to be held at Ormoc City sometime between October and November, this year;

"WHEREAS, one of the requisites of the holding of Provincial Meets is a decent athletic ground; and

"WHEREAS, the Ormoc City Central School athletic ground is still far behind the requirements and needs a lot of improvement to conform with the requirements, among other things, a grandstand; and

"WHEREAS, Ormoc City is financially hard pressed this time that it would seem impossible for the city to construct the required grandstand and improve the athletic ground all by herself;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Penserga;

"RESOLVED, as it is hereby resolved, to request the Honorable Daniel Z. Romualdez, Speaker of the House of Representatives, Manila, an aid of ₱10,000 for the improvement of the Ormoc City Central School athletic grounds preparatory to the holding of the Leyte Provincial Meet at Ormoc City sometime between October and November, 1958;


"RESOLVED FINALLY, to forward a copy of this resolution to Speaker Romualdez, HR, Manila.

"CARRIED, Unanimously."


