RESOLUTION NO. 124

"WHEREAS, a road right-of-way agreement has been entered into by and between the Honorable City Mayor of Ormoc representing the City Government, and Mrs. Clara de la Cerna as landowner, over a portion of Lot No. 584 owned by the latter, for the widening of Rizal St.;

"WHEREAS, the road right-of-way agreement covered an area of 43 square meters which the said owner, Mrs. Clara de la Cerna, is claiming payment at P15.00 per square meter on the premise that the lot is situated within the commercial zone; and

"WHEREAS, this Board, considering that this is an obligation of the city to the said landowner, sees the necessity of paying the claim as soon as funds become available for the purpose;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Penserga;

"CARRIED, Unanimously."


