"WHEREAS, with many years of experience behind him, Dr. Mandin is well qualified to become Assistant Director of Animal Industry;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Larrazabal;



"CARRIED, Unanimously."


