One : Clerk (from P1320 per annum) .....	1,440.00
One : Clerk .....	1,320.00
One : Clerk-typist (new) .....	1,020.00
One : Janitor-Messenger (new) .....	1,020.00
Two : Clerk-checkers at P6.00 per day, payable from projects in which engaged.	
3 : Clerk-checkers at P5.00 per day, payable from projects in which engaged.	


"RESOLVED FINALLY, to furnish copies of this resolution each to the Honorable, the Auditor General, Manila; the Honorable Secretary of Finance, Manila; the City Treasurer, and the City Auditor, both of Ormoc City.

"CARRIED, Unanimously."


