RESOLUTION NO. 140

"WHEREAS, Dr. Cristina Conui has filed a claim with this Board asking payment for her land affected by the widening of Mabini St., involving an area of 34 square meters as covered by a road right-of-way agreement signed by herself as landowner and the City Mayor of Ormoc in behalf of the city government;

"WHEREAS, the land, Lot No. 656, is situated in a section which has been appraised by the Appraisal Committee at P15.00 per square meter; and

"WHEREAS, this Board has made it a policy to help road right-of-way claimants by approving their claims and authorizing the payment therefor as soon as funds become available for the purpose;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claim of Dr. Cristina Conui for her land known as Lot No. 656 which was occupied and utilized by the city for the widening of Mabini St., hereby setting aside the sum of P510.00 to be made available for the purpose, as soon as funds become available;

"CARRIED, Unanimously."


