"WHEREAS, the City Engineer, this City, has submitted for approval by this Body, the Annual Road and Bridge Fund Budget for the fiscal year 1958-1959, duly approved as corrected by the Highway Division Engineer, 4th Engineering Division, Cebu City;

"WHEREAS, after a thorough study of same this Board finds that the proposed budget is in order except that the estimated revenue is short by P705.00, the amount which is supposed to be entered under item 8 (Transfer from General Fund) to make the total estimated revenue P75,235.00; and

"WHEREAS, this Body has already passed the annual appropriation ordinance for Ormoc City which embodies the City Counterpart Fund for the Roads and Bridge Fund;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Parrilla;

"CARRIED, Unanimously."


