"NOW, THEREFORE, the Board, on motion of Councilor Samson, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to reiterate the wishes of this Board as embodied in Resolution No. 131, c.s., hereby requesting again His Excellency, President Carlos P. Garcia to have Dr. Rosalio Mandin appointed as Assistant Director of the Bureau of Animal Industry, and requesting the President further, that Dr. Mandin's being a Boholano should not be a disqualification on his being appointed to the position;

"RESOLVED FINALLY, to forward the original of this resolution to His Excellency, President Carlos P. Garcia, Malacañang, Manila, and copies furnished each to Hon. Juan C. Pajo, Executive Secretary, Malacañang, Manila; Senator Decoroso Rosales, Manila; and Secretary Juan Rodriguez of the Dept. of Agric. & Natural Resources, Manila; and Congressman Dominador M. Tan, HR, Manila.
