RESOLUTION NO. 145

"WHEREAS, during the widening of Lopez Jaena St. the city utilized and occupied Lot No. 222 of the Ormoc Cadastre owned by Mr. Teodoro A. Sevilla with an area of eight (8) square meters which is covered by a road right-of-way agreement executed by the land owner and the City Mayor in behalf of the city;

"WHEREAS, the value of the land affected as appraised by the Appraisal Committee, this City, in unnumbered resolution dated November 22, 1957, is P8.00 per square meter; and

"WHEREAS, Mr. Sevilla is claiming payment for his lot, and this Board, considering that this is an obligation of the city to the said landowner, sees the necessity of paying the claim as soon as funds become available for the purpose;


NOW, THEREFORE, the Board, on motion of Councilor Penserga, seconded by Councilor Ocubillo;

"RESOLVED, as it is hereby resolved, to appropriate the sum of P64.00 as soon as funds are made available for the payment of road right-of-way claims, to be paid to Mr. Teodoro A. Sevilla as payment to his land aforementioned;

"CARRIED UNANIMOUSLY."


