RESOLUTION NO. 151
of

"WHEREAS, during the widening of the city streets, the government used and occupied 62 square meters of the lot owned by Soledad Sy situated at the corner of Rizal and C. Aviles Sts., particularly known as Lot No. 505 of the Ormoc Cadastre; and 51 square meters of land owned by Paulita C. Tan situated at San Agustin St., particularly known as Lot No. 774 of the Ormoc Cadastre;

"WHEREAS, the value of the lands affected as appraised by the Appraisal Committee, this City, in an unnumbered resolution dated November 29, 1957, is ₱20.00 per square meter for the former and ₱15.00 per square meter for the latter; and

"WHEREAS, the owners of the lots aforementioned are claiming payment for their land, and this Board, considering that this is an obligation of the city to the said landowners, sees the necessity of paying the claims as soon as funds become available for the purpose;


"NOW, THEREFORE, the Board, on motion of Councilor Du, seconded by Councilors Penserga and Gutierrez;

"RESOLVED, as it is hereby resolved, to approve the road right-of-way claims of Soledad Sy and Paulita C. Tan, hereby appropriating the sum of ₱2,005.00 for the payment of same, as soon as funds are made available for the purpose;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, Mrs. Paulita C. Tan and Mrs. Soledad Sy Velasquez, all of Ormoc City.

"CARRIED, Unanimously."


