RESOLUTION NO. 155

Letter of the City Engineer, Ormoc City, dated September 12,  
1958, quoted hereunder in full, follows:

Gentlemen:

In connection with the approved contract for the construction of the Alegria Slaughterhouse and Valencia Market Tiendas, certain items such as painting, installation of G.I. gutters and conductors were eliminated in the original contract price in view of the lack of funds available from the previous balance in the RFC loan. However, it was agreed that an additional loan will be applied for with the RFC to cover these eliminated items and other additional items which are very essential in the completion of the whole project. In the construction of the Alegria Slaughterhouse, the additional items needed to elevate the floor to the desired grades are the extra fill, grouted riprap, and the extra concrete class "A".

Aside from these, we are recommending the improvement of the market sidewalks along Real Street and the construction of the eaves of the Market Tiendas facing Rizal Street.

Attached hereto is the itemized estimate of the amount of (P20,000.00) recommended for additional loan with the RFC.


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to request an additional loan of Twenty Thousand Pesos (P20,000.00) from the RFC (now Development Bank of the Philippines), for the completion of the Alegria Slaughterhouse and the Valencia Market Tiendas, both in this City, and for the improvement of the Market Tiendas in the city proper, as per recommendation of the City Engineer in the above-quoted letter;

"RESOLVED FINALLY, to furnish copies of this resolution each to the RFC, Manila; the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.

"CARRIED, Unanimously."


