RESOLUTION NO. 156

"WHEREAS, Engr. Mike Clayton Betron, Jr., has filed an application before this Board for a permit to operate a radio-wired broadcasting station in Ormoc City, the purpose of which is to serve the public by means of giving the people music for entertainment and news through speakers connected directly to the homes of people who would wish to patronize the system;

"WHEREAS, this Board considering that the proposed station will serve the public at a minimum cost especially to those who cannot afford to purchase and maintain commercial radio receiver sets, sees that the system is just the kind of entertainment that the greatest mass of the people can afford; and

"WHEREAS, this Body further considers that the proposed system will benefit the people both morally and mentally through the series of educational programs which will be played over the system;

NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Penserga;

"RESOLVED, as it is hereby resolved, to approve the request of Engr. Mike Clayton Betron, Jr., hereby granting him the permit to operate in Ormoc City, a radio-wired broadcasting station in Ormoc City subject to the rules and regulations governing the operation of same;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer, the City Auditor, the City Engineer, the Fire Chief and Engr. Mike Clayton Betron, Jr., all of Ormoc City.

"CARRIED, Unanimously."


