RESOLUTION NO. 159

A RESOLUTION APPROPRIATING THE SUM OF ₱75,235.00 AS COUNTER-PART MAINTENANCE FUND FOR THE CITY ROAD & BRIDGE FUND.

"WHEREAS, pursuant to Sec. 9(b) of RA 917 this Board is required to provide in the annual road and bridge budget an appropriation for the maintenance of existing and unabandoned roads, streets and bridges of this city, actually serving motor vehicular traffic, designated by this Board, equal to at least one-half the total maintenance requirement, as Counterpart Maintenance Fund, to be taken from our local Road and Bridge Fund;

"WHEREAS, in order that the national aid from the Highway Special Fund for the maintenance of city roads, streets and bridges may be released it is required that the counterpart appropriation from our local funds shall be certified to by the city treasurer, and made available for expenditures by the Division of Highways;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla seconded by Councilor Ocubillo;


"RESOLVED, as it is hereby resolved, that the amount of ₱75,235.00 be appropriated from the city road and bridge fund as Counterpart Maintenance Fund, pursuant to Sec. 9(b) of RA 917;

"RESOLVED FURTHER, that the City Treasurer be instructed to prepare the corresponding Road and Bridge Fund Budget, and to make the aforestated appropriation available for expenditures of the Bureau of Public Highways, for the purpose hereinbefore mentioned, withdrawable as advance fund by the Disbursing Officers of said Bureau, duly authorized for this purpose;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Accounting Section, Bureau of Public Highways, Manila, for their information, with the request that the corresponding national aid be promptly released; the City Treasurer and the City Auditor, both of Ormoc City; the Highway Division Engineer, 4th Engineering Division, Cebu City; and the City Engineer, Ormoc City.

"CARRIED, Unanimously."


