RESOLUTION NO. 160

"WHEREAS, the construction of a new slaughterhouse at Bo. Alegria would mean the demolition of the old slaughterhouse at Mabini St., for then it would no longer be of service to the city;

"WHEREAS, the Chief of Police, in a letter to this Board dated October 8, 1958, has requested that the materials demolished from the old slaughter house be allocated to the Police Department so that the same can be reconstructed into a garage for the two jeeps of the Police, and at the same time utilized as a lecture and recreation hall; and

"WHEREAS, this Body considers the necessity of a garage for the jeeps of the Police Department when not in use in order to conserve the usefulness of these jeeps;


"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to direct the City Engineer, this City, to turn over the materials demolished from the old slaughter house to the Police Department, so that the same may be reconstructed into a garage for the two jeeps of the Police, and at the same time to be utilized as a lecture and recreation hall;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Engineer, the City Treasurer, the City Auditor, and the Chief of Police, all of Ormoc City.

"CARRIED, Unanimously."


