RESOLUTION NO. 162

"WHEREAS, His Highness, Pope Pius XII had in many occasions in life dared and even led the fight against the evils of communism and the unjust and undue oppression of weaker peoples;

"WHEREAS, His Highness, Pope Pius XII, through a lifetime work and struggle, had contributed much to the preservation of the democratic way of life as befit the Christian way;

"WHEREAS, the Catholic World, as well as all the other peoples on earth, have been the beneficiaries of the lofty principles and the heroic efforts of His Highness, Pope Pius XII, precisely during this critical times when Humanity and all the living beings on earth are at the brink of total annihilation and extinction; and

"WHEREAS, the people of the City of Ormoc have likewise been the beneficiaries of the wise spritual guidance of and the numerous Blessings from His Highness, Pope Pius XII;

"NOW, THEREFORE, the Board, on motion of Councilor Gutierrez, seconded by all the members of the Board present;

"RESOLVED, as it is hereby resolved, to extend the profound sympathy of this Board in representation of the people of Ormoc City, to His Excellency, Mons Egidio Vagnossi, Apostolic Nuncio, Manila, and express our griefs and sorrows for the death of His Highness, Pope Pius XII;

"RESOLVED FINALLY, to furnish copies of this resolution each to His Excellency, Mons. Julio Rosales, Archbishop of Cebu; and to His Excellency, Mons. Lino Gonzaga, Bishop of Palo, Leyte.

"CARRIED, Unanimously."
