RESOLUTION NO. 164

"WHEREAS, the NWSA office, this City, has billed the city government for water consumption at the City Hall from January to August, 1958 at ₱20.00 per month, and for water consumption of public faucets at Bo. Bantigue at ₱5.00 per month from March to August, 1958, totalling ₱190.00;

"WHEREAS, inasmuch as the water has already been consumed during the period mentioned in the bills, it therefore becomes an obligation of the city to pay said water consumption;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Gutierrez;

"RESOLVED, as it is hereby resolved, to authorize the City Treasurer, Ormoc City, to pay to the NWSA, this City, the sum of ₱190.00 to represent payment of water consumption at the City Hall from January to August, 1958, at ₱20.00 per month, and water consumption of public faucets at Bo. Bantigue, from March to August, 1958, at ₱5.00 per month, hereby appropriating for the purpose, the amount of ₱190.00 from out of any funds existing in the city treasury not otherwise appropriated;



"CARRIED, Unanimously."


