RESOLUTION NO. 169

"WHEREAS, it has come to the knowledge of this Board that City Attorney Ramon Am. Torres, of Ormoc City, is going to Manila on official business under permission of the Secretary of Justice;

"WHEREAS, as this Board has learned, the City Attorney is going there for a conference which will last about three or four days;

"WHEREAS, after said conference, City Attorney Torres can attend to other official matters pertaining to Ormoc City which are now pending in national offices in Manila, like the city budget which is now in the Department of Finance;

"WHEREAS, in the past two years, the Department of Finance had always insisted and had issued directives to this Board to appropriate the necessary funds to cover the salaries of the positions abolished by Resolution No. 8, series of 1956 in view of the filing with the Court of First Instance a case of Mandamus and Quo Warranto by those affected by the abolition; and

"WHEREAS, this Board believes that the City Attorney, who had been handling these Quo Warranto cases in behalf of the city and who as a matter of fact has successfully convinced the Court to dismiss some of these cases, is the most appropriate or the most competent person to make representations with the Department of Finance to explain and settle this case once and for all, in order to avoid the possibility of the Department's making another directive to this Board to appropriate funds for these abolished positions;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Tan, Jr.;

"RESOLVED, as it is hereby resolved, to officially delegate the City Attorney, this City, to make representations with the Department of Finance, Manila, regarding that matter of directing this Board to appropriate funds for the abolished positions which is a closed matter, hereby allowing him for the purpose, to prolong his stay in Manila after attending the conference,

which is the main purpose of his travel.

"RESOLVED FURTHER, to allow the City Attorney, to draw a cash advance of P300 to defray subsistence and transportation expenses during his travel, chargeable to the current appropriation for traveling expenses of the Office of the City Attorney;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Secretary of Finance, Manila; the Secretary of Justice, Manila; the City Treasurer, the City Auditor and the City Attorney, all of Ormoc City.

"CARRIED, Unanimously."


