RESOLUTION NO. 17A

"WHEREAS, Councilor Parrilla presented before the Board a voucher in favor of Eulogio Maglasang covering payment of his accumulated and unenjoyed vacation and sick leaves as Patrolman of the Ormoc City Police Department;

"WHEREAS, the Board was made to understand that the said voucher was already presented for pre-audit, but that the City Auditor refused to pass same in audit in view of existing regulations to the contrary;

"WHEREAS, the City Auditor, who was summoned to the Board to explain his refusal to pass in audit the said voucher, said the termination of Pat. Maglasang from the service was "for cause" as had been enumerated in the letter of termination of services; and

"WHEREAS, this Body considering that Pat. Maglasang has earned these accumulated leaves in the service, decides that he should be paid of the money value of same;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilor Samson;

"RESOLVED, as it is hereby resolved, to authorize the City Auditor, this City, to pass in audit the claim of Eulogio Maglasang for payment of his unenjoyed accumulated vacation and sick leaves
