RESOLUTION NO. 176

"WHEREAS, a petition addressed to His Excellency, the President of the Philippines, has been coursed through this Board by the "Confederation of Western Leyte War Veterans" petitioning His Excellency to order the Bureau of Lands to allot Block No. 1, Alienable and Disposable area at Ormoc City, for the purpose of settling and developing such uncultivated area of Ormoc City into agricultural settlement;

"WHEREAS, the head of the petitioners, Atty. Sofronio D. Aguipo, in a letter to this Board accompanying the petition, stated that said Block No. 1 subject of the petition, was already released by the Bureau of Forestry to the Bureau of Lands as alienable and disposable area for agricultural purposes;

"WHEREAS, the same letter of Atty. Aguipo only requested this Board to indorse favorably their petition; and

"WHEREAS, this Board, considering the plight of the petitioners to own a piece of land which they can call their own for the benefit of their family, offers no objection to the settlement for agricultural purposes of the aforesaid Block No. 1;


"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Du;

"RESOLVED, as it is hereby resolved, to indorse favorably, the aforesaid petition, hereby requesting His Excellency, the President of the Philippines, to order the Bureau of Lands to allot Block No. 1, Alienable and Disposable area at Ormoc City, to the petitioners for the purpose of developing the same into an agricultural settlement;


"RESOLVED FINALLY, to furnish a copy of this resolution each to the Director of Lands, Manila; and Atty. Sofronio D. Aguipo, Ormoc City.

"CARRIED, Unanimously."


