RESOLUTION NO. 17

"WHEREAS, the Chief of Police, this City, in a letter to this Board dated October 28, 1950, requested the passage of a resolution making representations with the PC to octhhold delivery of three firears row in the custody of the folice Department and which are issued to the members thereof;

"WHEREAS, be it known to the PC authorities concerned that the Police Force of Cranc City is greatly in need of these arms in view of law of arms for its members; and

"WHEAKAS, this Body believes that the PC at Ormoc City has evough arms for its personnel even without these three firearms;

W, THEFAIL, the Board, on motion of Councilor Du, seconded by Councilors Penserga and Parrilla;

"NEONED, as it is hereby resolved, to request the Provincial Commandor, Tacloban City, through the Commanding Officer, 59th PC Company, Camp Downes, Ormoc City, to temporary lend the three fire-agas - one revolver Colt, Cal. 45 SN 79307-230954, one US Pistol Ithaca, Cal. .45 SN 1277172, and one US Pistol Remington Rand Cal. .45 SN 903 - to the Police Force of Ormoc City, until such time that the city government will be able to purchase the necessary firearms for the said force;

"RESOLVED FINALLY, to furnish copies of this resolution each to the Provincial Commander, Camp Bumpus, Tacloban City; the Commanding Officer, 59th PC Co., Camp Downes, Ormoc City; and the Chief of Police, Ormoc City. "CARRIED, Unanimously."
