RESOLUTION NO. 182

"WHEREAS, it has been brought to the attention of this Board that there are tiendas constructed by some private individuals inside the athletic grounds of the city central school purportedly upon permission from certain school authorities;

"WHEREAS, reports received by this Board are that some private individuals are destroying a division project inside the athletic grounds, the "balayans", just to accommodate their tiendas; and

"WHEREAS, this Board deems it wise to discourage these tiendas inside the athletic grounds so as to avoid the sale of liquor;

"NOW, THEREFORE, the Board, on motion of Councilor Ocubillo, seconded by Councilor Parrilla;

"RESOLVED, as it is hereby resolved, to request the school authorities to discourage and not to allow private individuals to have their tiendas or canteens inside the athletic grounds of the city central school during the provincial meet to forestall the possibility of the sale of liquor inside the athletic grounds during the meet, to protect and preserve the division projects and to avoid interference during the games;


"RESOLVED FINALLY, to furnish copies of this resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisor, Ormoc I District; and the Administrative or the Managing officials of the Meet, care of the District Supervisor of Ormoc I, Ormoc City.

"CARRIED, Unanimously."


