RESOLUTION NO. 183

"WHEREAS, during the widening of the city streets, the government used and occupied 28 square meters of land owned by the spouses Dr. Alvaro I. Gutierrez and Adelaida Pifion situated along Lopez Jaena Street, particularly known as Lot No. 575-B of the cadastral survey of Ormoc;

"WHEREAS, the value of the land affected according to the schedule of values of city lots located in the business section is ₱30.00 per square meter;

"WHEREAS, the land owners above mentioned are claiming payment of their lot which had been covered by a road right-of-way agreement; and

"WHEREAS, the payment of the aforesaid lot is an obligation of the city government to the landowners to compensate for their property used by the city for road purposes;

"NOW, THEREFORE, the Board, on motion of Councilor Parrilla seconded by Councilors Du and Penserga;

"RESOLVED, as it is hereby resolved, to approve the claim of the spouses Dr. Alvaro I. Gutierrez and Adelaida Pifion for payment of the lot used by the city to widen Lopez Jaena St., hereby appropriating the sum of ₱840.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment thereof;


