RESOLUTION NO. 184

"WHEREAS, in a letter to this Body dated November 11, 1958, the City Auditor, this City, requested the reversion of the sum of ₱1,800.00 from the salary savings of his office distributed as follows: ₱1,500.00 to be reverted to account C-3-f; ₱300.00 to be reverted to account C-3-t;

"WHEREAS, the same letter stated that the amount of ₱600.00 appropriated in the current annual budget for the first item is inadequate to defray traveling expenses that may be incurred by the employees in connection with their trips for inspection, supervision and conferences and the subsistence of Mr. Gregorio R. Gaidie who is to be detailed as Assistant City Auditor in this City meanwhile that the budget is not yet approved; while the second item's appropriation of ₱200.00 has already been exhausted;

"WHEREAS, this Body considering that the amount requested is already appropriated for the same office for salaries and wages but not utilized, offers no objection to its reversion as requested;


"NOW, THEREFORE, the Board, on motion of Councilor Parrilla, seconded by Councilors Gutierrez and Du;

"RESOLVED, as it is hereby resolved, to revert the sum of ₱1,800.00 from out of the salary savings of the office of the City Auditor, distributed as follows: ₱1,500.00 to account C-3-f; ₱300.00 to account C-3-t;


"RESOLVED FINALLY, to furnish copies of this resolution each to the City Treasurer and the City Auditor, both of Ormoc City.

"CARRIED, Unanimously."


